SELECTION

Select a gun to match your system flow and pressure requirements, temperature and function being performed. When operating in freezing conditions the weep model is recommended.

INSTALLATION


Install the appropriate regulator or unloader when using a shut-off gun to avoid pressure spikes when the gun is shut off. Severe damage can occur to your system without this safety device. For field conversion, a shut-off gun may be modified to a weep gun by changing the seat (item 612) to a notched seat. It is recommended that the color coded safety latch also be used when converting to a weep gun.

OPERATION

Squeezing the trigger on the gun activates the actuator rod, lifting the ball off the seat, allowing the pumped liquid to flow through the valve body chamber. Releasing the trigger shuts off the flow.

A special safety latch locks the gun closed to prevent unintentional operation when left unattended. This latch is black on the shut-off model and blue on the weep model.

Do not allow spray to contact any part of the body or animals. Pumped liquids under high pressure can pierce skin and underlying tissue or can deflect debris leading to serious personal injury or death.

- 1. Relieve all line pressure in the inlet line to the pump and discharge line from the pump before performing any maintenance on the gun.
- $2. \ When high-pressure gun is not in use, set safety trigger lock (safety latch) to avoid accidental high-pressure operation and personal injury or property damage.\\$
- $3. \ Do \ not \ check for \ leaks \ with \ hand. \ Use \ a \ piece \ of \ cardboard \ to \ check for \ leaks.$
